

#### **Our** Collective Aims Since April 2019

- Reduce maternal mortality and morbidity
- Improve Identification of and Care for Pregnant and Postpartum Women with Opioid Use Disorders (OUD)
- Improve Identification of and Care for Opioid-Exposed Newborns (OEN)

### **YOU** Led 107 QI Projects!

**38** around NAS

22 around maternal OUD + 9 around immediate postpartum LARC

**38** around other maternal mortality-related topics (hypertension or hemorrhage)

#### **YOU** Impacted Structure Measures! Baseline compared to July-September 2020

### Expanded Focus on NAS/OUD

#### In 2021, Let's Build on and Finish what YOU Started:


- Screen all pregnant women for SUD/OUD using validated screening tools
- Establish specific prenatal, intrapartum and postpartum clinical pathways for women with OUD, and engage them in MAT treatment during pregnancy and postpartum
- Increase access to immediate postpartum contraceptive options, including LARC
- Standardize non-pharmacologic and pharmacologic care for NAS

#### In 2021, Let's Take the Next Step and Ensure the Dyad is Connected to Wrap-Around Support:

- Provide home visitation post-discharge for mothers and infants exposed to opioids in partnership with health plans and counties
- Create a safe environment for the infant by connecting the mom and baby dyad to wrap around supports prior to discharge
- > Care for the mom and baby dyad for 15 months through well-child visits

#### Updated ONAF Went Live on Nov. 13

#### The OB Needs Assessment Form (ONAF) / OB Care

- Notifies PA Medicaid of pregnancy, initiating enrollment in the Maternity Program
- Allows PA Medicaid to risk-strategy members and refer to care management programs

#### **Tips for OB Care**

- > In prenatal section, depression screening fields appear if "depression present" is "yes" so for negative screens, document in "Additional Notes"
- > In prenatal section, if you are using a validated SUD screen that does produce a score, enter "0" as the score and note this in "Additional Notes"
  - In the future, Optum will be adding a test string that says, "When using a screening tool without a numerical score, enter a "1" for a "Positive" result or a "0" for a "Negative" result.
- In the postpartum section, in rare cases where "PP depression present" is "yes" but a validated screen was not administered, select "Other" from the screening list and explain this in the "Other Depression Tool Used" text field that appears
